- 1. (a) Suggest a suitable data structure that can hold the responses to a set of 100 questions, where each response is either "yes" or "no". Include reasons for your suggestion.
 - (b) Using the data structure suggested in part (a), construct the method yesTotals() that will return the total number of "yes" responses. The method has been started below.

public int yesTotals()

The method numberSorter() receives an int array of unknown length (but with a maximum of 100 items), and places the integers into three different arrays a, b and c, where

a = negative integers
b = non-negative even integers
c = integers neither in a nor in b.

The method then returns the number of items in array b.

(c) Construct the method numberSorter(), which has been started below. You can assume that the arrays are initially empty.

- 2. A *master file* has been created that contains details of the players in a soccer (football) league. Each record in the file contains the name of the player and the total number of goals that they have scored. The records are stored in alphabetical order of the players' names.

The first three records are shown below:

Record 0		Record 1		Record 2		
name	goals	name	goals	name	goals	
Adams P.	5	Alvez J.	1	Aziz M.	3	

The master file is updated each week by a transaction file.

(a) Outline the differences between a master file and a transaction file.

Each week the following processing then takes place:

- a user inputs data into a new transaction file which has the same record structure as the master file and which contains details of the goal scorers for that week
- the transaction file is sorted into the same order as the master file
- the master file is updated by the transaction file
- the total number of goals scored that week is printed out.
- (b) Draw a systems flowchart for the above processing.

For the update process to take place, the records in the master file are read into the array master[], which is an array of Player objects. A Player object is defined by the class Player, shown below.

```
class Player
{
    public String name; // name of player
    public int goals; // number of goals scored by that player
}
```

The records in the transaction file are read into the array transaction[] which is also an array of Player objects.

(c) Explain why it is important to have both the master file and the transaction file in the same order. [2 marks]

 - (ii) master[2].goals. [1 mark]

The update process is as follows:

repeat for each player in the array transaction[]

- search sequentially in the array master[], until the same player is found
- update the number of goals scored for that player.

The method update() performs this process and **also** returns the total number of goals scored for that week.
