



The first point is a description. Point 2 is inaccurate and not awarded marks. The final point is given as an outline - reference to the graph is not accurate.




Question 3 (20 marks)




























Evaluate the economic advisor's investigative process.

You must consider the investigative process rather than the economic advisor's presentation skills. In your response you should consider:

- The sources used
- How successful the investigation was.

The economic advisor's investigative process was done correctly and provided the correct message and information. the presentation informed about the problem and about the issue that Australia are currently in with the aid. The economic advisor used reliable sources to suport her arguement and those sources were the World Health Organisation and Australian government official website, she also stated that they were reliable which supported her in proving her point.

The sources used were visual sources that showed the different pieces of information she wanted to tell in a very clear and orginised way, this made her investigation appear more successful since it helped the viewer understand the topic much easier.

The presentation included information about Sierra Leone and is current issue and informed about the possible help that could be provided however isn't; which supports the argument.

The presentation is missing a lot of important information like how Australia may help, how much would it cost and examples of other similar cases.

Even though there is an appraisal the student does not meet the detail needed for the descriptor 'describe' and overall best fit puts the student at a 5.

Imagine a company wants to extract natural resources from a community of your choice. You should use the sources and/or knowledge from your MYP studies to **discuss** whether the economic benefits outweigh the environmental concerns.

In your essay you should:

- Name the community and resource that you have chosen
- · Consider the economic benefits
- Consider the environmental concerns
- Consider possible perspectives of the local residents and the resource extraction company
- Include a conclusion to state whether you think the economic benefits of the resource extraction outweigh the environmental concerns.

The resource that i will be discussing is Shale Gas which is presently found in America. Shale gas is considered to be a highly contro versial source of energy because of the various advanatges and disadvantages that it brings to the society and the environment respectively.

According to The video given in Source E, Shale gas can be found in 106,400 tons within the United States. Globally, it is estimated that there is enough to provide for 140 years of global gas consumption at current levels through the production of shale gas. This could not only benefit America which is the country that produces it but it could also affect the world since gas has a high demand of 4 billion tonnes in demand by the year 2030, according to slide 2 from source E. The price of oil is also 20% lower than what it was supposed to be otherwise because and Natural gas is 80% cheaper in America than the rest of the world. Not only does Shale gas reduce prices for citizens, it also provides employment all over the country because the process of fracking the shale gas offers high paying jobs. Fracking also benefits the government of the America because ethey pay far more their income as taxes and fees than any othe rindustry because of the resources that they use which are involved in the process.

However, there are also multiple limitations involved with the process of producing shale gas since it occurs underground which could cause leaks and the pollution and contamination of clean drinking water source according to Slide 1 in Source E.





The children population in the 2050 graph for children aged from 10-14 has a higher number (around the 400 thousands) then the 201 4 graph.

In the age groups of 80-89 in the 2050 chart, the population has increased from 2014.

The overall data for the 2014-Sierra Leone population pyramids shown exponential decrease as the highest point is from age group 0-4 and keeps on decreasing from there. The 2050 pyramid show a much slower decreasing gradiation, much less steeper and sever e than in 2014.


Question 3a (4 marks)




























Evaluate the economic advisor's investigative process.

You must consider the investigative process rather than the economic advisor's presentation skills. In your response you should consider:

- The sources used
- How successful the investigation was.

The economic adivisor's investigate process included many sources that were relevant to the subject that was being discussed. In the e second slide she discussed the number of cases of Ebola in Sierra Leone in contrast to the number of cases of Ebola to other West African countries such as Guinea and Liberia. She used a clear graph that demonstrated the numbers and supported her argument very well. In the next slide she discussed how quickly the death roll has risen. The source she used did not exactly demonstrate this argument. It gave factual information on in which sections have the largest amount of deaths as of March 2015 but it did not compar e the amount of deaths to a previous year. Therefore, she did not have any facts that supported her argument in stating that the deat h toll has guickly risen as we do not know what it was like before March 2015. The next slide discusses the Australian parliament's aid budget. She uses a graph from the Australian's government's official website in order to demonstrate how throughout the last few years (especially since the year 2012-2013) the amount of financial aid that Australia has been giving to many countries has decreased. Her source clearly states this as well as how the country will continue to cut their budget. As the presentat ion continues she demonstrates how Australia prides itself in their efforts to combat poverty and disease due to the amount of money they give for aid. It lists 12th with an amount of 3.7 billion US dollars. She states that Australia has contributed to international huma nitarian aid from 2003-2012 but her source does not show this prominently. Her source does not provide any specific dates or comp arisons throughout the years it just states that they have funded 3.7 billion US dollars, unsure of what year this number has been pull ed from as well. The next slide discusses how she could not find information and facts to support how Sierra Leone has decided to u se their aid. This would of been a good argument to give as it would allow the people to know where their money has been put towar ds and for them to be reassured that it is being spent visely. In the seventh slide, she discusses how Australia's aid distribution curre ntly looks like. She uses a pie chart to depict what percentage is being used in each section. The only issue with this source is that we are unsure how much money is being put towards the aid as we are only given the percentage that is being used but not what we are starting off with. In the next slide she discusses how she thinks the pie chart to change in order for the aid to be beneficial. In the last few slides she goes over the aid budget cuts which we had seen previously and proposes that we do not cut them. The only issu e with this research is that she gives no arguments on how they government would keep on getting all this money from and if the pop ulation would be willing to donate more.


Overall, her presentation was very clear and the information she provided was good. Her argument was convincing but I do not think she had enough present facts to prove that her argument could be done. Some key information was missing as well as some of the data was incomplete as we do not have prior knowledge to the situation in Sierra Leone. I believe her investigation was successful b ut I would say that it could definetly be improved.





- Include a conclusion to state whether you think the economic benefits of the resource extraction outweigh the environmental concerns.

Natural resources are a commodity that every country needs. It can help the population of a country or it can be traded for economic purposes. Fracking is a highly controversial process that extracts resources from the ground in a quick and effective manner. In this essay, I will be mentioning fracking's economic benefits, environmental concerns, the perspectives of both the residents in America a nd the resource extraction company on the extraction of oil, and my opinion on fracking.

One reason why fracking is a commonly used process in extracting resources from the ground, is because of the numerous economic benefits it provides. In America, fracking has led that natural gas price to be 80% cheaper than the rest of the world. These low gas prices has led to growth in America's manufacturing sector.
